FOCUS - PARTNER TRAINING NEEDS

This month's focus is on assessing our Partner's current training needs. I know you are used to getting emails from SIP and other agencies/groups on various training opportunities being offered around the state, but we also need your feedback on your organization's current training needs to make sure we're bringing you the right mix of offerings.

A key piece, as we work with our partners around the state to bring in these training opportunities, is determining the "actual level of interest" in attending the training in different areas of the state. I'm planning to occasionally use these monthly Collaborative Corners to solicit your interest in certain training opportunities.

In addition to the training and assessments that Safeguard Iowa offers for our partners, we are often contacted by other organizations that are willing to sponsor or conduct training. Our partners at Iowa Homeland Security and Emergency Management are currently considering an offer from the University of Tennessee Center for Agriculture Food and Food Security and Preparedness (CAFSP) to provide the recently certified, new FEMA course, MGT489: Managing Public, Private and NGO Partnerships to Prepare for and Solve Critical Logistics and Supply Chain Challenges during Large Scale Disasters.

This is a "management level" course with a target audience of public and private sector disaster logistics and supply chain stakeholders; Emergency management personnel and logistics and planning staff; Councils of Government; Councils of Area Development Districts; Non-profits and planning organization representatives; Private sector organizations and associations.

The course is broken down into a prerequisite of Web Based Training (WBT) of AWR425W, followed by a 2-day in-person course. The attached PDF has additional info: MGT489 Course Announcement.pdf

BUSINESS CONTINUITY

According to FEMA, nearly one in three businesses in the United States will be impacted by a natural or man-made disaster in the course of their existence. As a result, 40 percent of those businesses do not reopen and another 25 percent fail within the first year following the disaster. In spite of these scary facts, nearly 80 percent of businesses do not have an emergency operations or business continuity plan.

Are you looking for Business Continuity training for small and medium sized businesses in your area of lowa? Safeguard lowa Partnership can facilitate a Business Continuity Workshop to help your area businesses with the process of developing these plans. The training will provide interactive tools, templates, and subject matter experts to help get them started in the planning process to


